Firstly, Hoang Anh Gia Lai Agricultural Joint Stock Company ("Company") would like to send you a wish of health and respectful greeting.

Hereby, Hoang Anh Gia Lai Agricultural Joint Stock Company (Stock code: HNG) explains the fluctuations in business results in the Separate Financial Statements for the Quarter II of 2016 as compared to those for the Quarter II of 2015 as follows:

- Profit after tax in the Quarter II of 2016: VND 16 billion
- Profit after tax in the Quarter II of 2015: VND 789 billion

#### **Description of the fluctuations:**

## 1. Business operations

- Revenue from sales and services in the period increased by 24 billion as compared to that in the same period of 2015 (Quarter II/2015: VND 7 billion; Quarter II/2016: VND 31 billion). The fluctuation is mainly due to the income of selling seedlings increased.
- Corresponding to the fluctuations of revenue, the cost of goods sold in the period increased by 22 billion as compared to that in the same period of 2015 (Quarter II/2015: VND 6 billion; Quarter II/2016: VND 28 billion).

## 2. Financial operations

- Financial income in the period decreased by VND 642 billion as compared to that in the same period of 2015 (Quarter II/2015: VND 872 billion; Quarter II/2016: VND 230 billion). The fluctuation is mainly due to the decrease of dividends received from subsidiaries
- Financial expenses in the period increased by VND 129 billion as compared to that in the same period of 2015 (Quarter II/2015: VND 58 billion; Quarter II/2016: VND 187 billion). The cause is mainly due to the increase of interest costs. There are some loans incurred in the period.

## 3. Investment operations

The losses from associated companies in the period increased by VND 15 billion as compared to that in the same period of 2015 (Quarter II/2015: 0 billion, Quarter II/ 2016: VND 15 billion).

The Company's other operations have been going on normally with no considerable fluctuations.
